There is much to do at this time for Nomination Grand Pré. The management plan is progressing well and a new draft should be ready soon.

A draft of the Nomination Proposal will be ready to submit to the Advisory Board at the next Advisory Board meeting on July 8, 2010.

Project Manager's Progress Report

Progress on the Nomination Proposal

We are still aiming to submit a nomination proposal next February, which brings us now in the first stages of review of a draft. The draft includes all the chapters required in the nomination proposal, meaning a statement about the proposed outstanding universal value, a description of the legislation and policies that protect it, a description of the proposed site's integrity and authenticity, a management plan, an explanation of how the site is going to be managed, and a description of how the condition of the site will be monitored.

The statement of outstanding universal value that was approved in 2009 is being modified to respond to UNESCO's expectations of clearly articulating why the landscape Grand Pré and area is of universal value. The proposal is still about the dykelands, the landscape, the memorials, and agriculture but the actual words in the statement will change. It is a challenging exercise because the landscape of Grand Pré and area is compared to sites around the world and over thousands of years of cultural history. A tall order indeed, but one that we feel confident can be done.

The management aspect is progressing well. As stated before, the incredible stewardship of the people of Grand Pré and area has been instrumental in protecting the nominated site. This is something that is recognized in the proposal and is central to the future of the site. The management plan explains how the municipal, provincial, and federal governments that already have authority for activities in the area will work together with residents and key stakeholders to protect the outstanding universal value. We envision that to secure that collaboration and the fundamental role of the residents and stakeholders in managing the site, a governance board needs to be set up to advise those departments and ensure the effective stewardship of the nominated site.

The information included in the draft is the most accurate we can provide as of June 2010, since there are numerous aspects of management that are still not complete. We will be modifying the information in future drafts as those aspects become clearer.

A draft will be reviewed by the Advisory Board at its meeting on July 8^{th} . Following that discussion, a draft will be sent to the Canadian Delegation to the World Heritage Committee for their review as they are actually the ones officially submitting the proposal to UNESCO. If they are satisfied with the progress made, a draft is then sent to UNESCO in September for voluntary review. This allows us to get feedback about the quality of the proposal. Based on that feedback we will be able to assess whether we are ready to formally submit in February of next year.

Nomination Grand Pré Highlights the Importance of Protecting Agriculture and Agricultural Land

The Agricultural Land Review Committee requested input in May from the public on the challenges and opportunities regarding the protection of agricultural land. Nomination Grand Pré provided a statement regarding the aims of the nomination proposal to UNESCO, the values associated with agriculture, and the strategies that were essential for the protection of the dykelands at Grand Pré. The statement was extremely well received by the Committee and further thoughts were asked to Nomination Grand Pré about the need to invest in the protection of the dykes and the importance of supporting the industry in Grand Pré and area. In addition to that statement, Nomination Grand Pré has sent a statement to the committee working on the Province of Nova Scotia's Coastal Strategy. That statement highlights the importance of recognizing cultural, historic, and economic value of dykelands and of the agricultural communities living along the coast. In addition, we are highlighting the importance of considering the protection of archaeological heritage, since many of the settlements from the Mi'kmaq to the later European settlers are often found along the coast. Both these aspects are important to Grand Pré and area in the context of the nomination proposal. We are inviting the committee to work with communities and invest the resources necessary to ensure that these goals are achieved. International Experts Visit Grand Pré


